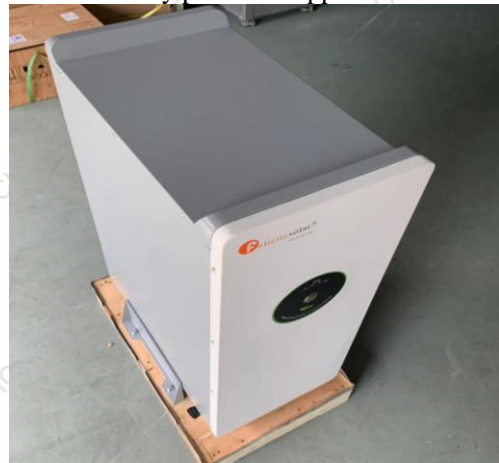

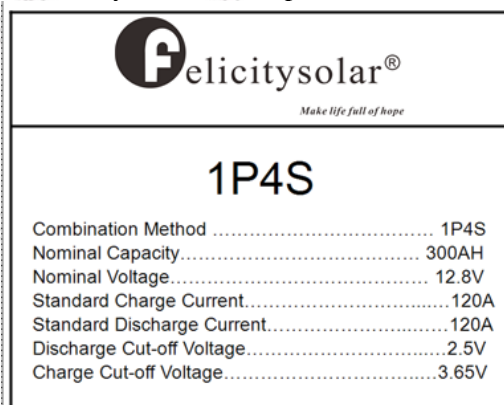

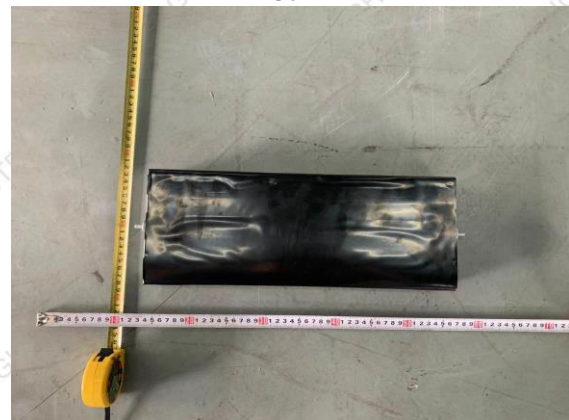
电池模组正面外观
